FARRELL BEARINGS LTDTERMS AND CONDITIONS

1. Terms of payment are 20<sup>th</sup> day of the Month following date of invoice.
2. Ownership in the goods sold is retained by the company Farrell Bearings Ltd until payment is made for the goods and for all other goods supplied by the company to the customer. If such goods are sold by the customer prior to payment therefore and if they shall become constituents of any other goods then the proceeds of sale thereof shall be the property of the company Farrell Bearings Ltd.
  - a. The customer shall at the request of the company store the goods marked property of Farrell Bearings Ltd.
  - b. The proceeds of sale of the goods shall be kept in a separate account in trust for Farrell Bearings Ltd.
3. Delivery of goods is deemed to have been made and become the purchaser's risk as soon as they leave our premises.
4. All goods returned must be in the same condition in which they were when supplied. All goods must have the original invoice number and date. The company reserves the right to charge a rehandling fee.
5. Indented Goods are not returnable.
6. Any claim against the company is to be limited to the invoice value of the goods and liability for consequential damage is excluded. All claims and disputes are made to Farrell Bearings Ltd within fourteen (14) days.
7. The company shall not be responsible for any damage whatsoever caused in the event that the products are fitted, serviced or operated incorrectly, or if such products are in any way adapted to a use for which they are not intended.
8. That under the terms of the Privacy Act (1 July 1993) that you authorise any person or company to provide us with such information as we may require in response to our credit enquiry's. That you authorise us to furnish to any third party, details of this application and any subsequent dealings that you may have with us as a result of this application being actioned by us.
9. That you undertake to pay the account in full on or before the due date. In default of such prompt payment, you undertake to pay late payment fees of 2 ½ % per month on any amount outstanding and to indemnify us and pay all costs and expenses, which we may incur recovering from you, any overdue account.
